1. Applicant is required to submit dues (prorated monthly) along with the application fee when applying for full membership. A breakdown of these fees is listed below.

If you or your spouse are currently on active military duty, you are exempt from local, state, and national dues. Membership dues are nonrefundable.

2. Applicants must complete the New Member Orientation course within the next two scheduled classes after application has been submitted. The following 2012 dates have been established by the Education Committee for orientation classes, which include the National Association of REALTORS® mandatory Code of Ethics training: **3/22, 7/26, 11/1**. All new members will receive an invitation, which will be sent to their office several weeks prior to the course date. *Due to scheduling conflicts or space restrictions, the dates are subject to change; attendees will be notified of any changes.*

Failure of applicant to complete the New Member Orientation course within the allotted timeframe will be reported to the Board of Directors. At the discretion of the Board, dues may be returned to the applicant minus the application fee, and a statement will be sent to the broker based on the dues formula procedure. In the event membership is denied, the applicant must also return their Supra key to the Association office.

If you are applying for secondary membership, you may not be required to attend the New Member Orientation program. A letter from your primary REALTOR® association will be requested.

3. If a member resigns from another association with a pending ethics complaint or arbitration against them, the Greater Gateway Association of REALTORS® may restrict membership. The applicant shall submit to the pending ethics complaint or arbitration proceedings (in accordance with the established procedures of the association) and will abide by the decision of the hearing panel.
